Suspect Details

On 12-1-15 I was assigned to the Community Policing Division operating a fully marked cruiser and wearing a police mountain bike uniform. At approximately 1130 hours I began paying special attention to the area of Interstate 293 and South Willow St. There have been several subjects standing at each corner for the last several weeks collecting money and items from passing vehicles. When I arrived I observed a female standing on the east side of South Willow St at the west bound off ramp. She was holding a sign which stated she was homeless and asking for help. She was later identified as:

Candace Neal

Shortly after arriving I observed the traffic turning south onto South Willow St from 293 begin to move as the light had turned green. The second vehicle in line in the lane closest to Neal moved forward but then stopped to pass something to Neal. This sudden stop caused approximately the next four vehicles in line to stop unexpectedly and wait for the second vehicle to begin moving again. Neal reached out to the stopped vehicle and took something.

Once the traffic was clear I made contact with Neal and explained that her actions had caused the traffic to be disrupted and issued her a white summons for Disorderly Conduct (V).

On 12-06-15, at approximately 1600 hrs, I (Officer Karoul) was riding as a two man unit with Officer Rondeau in a plain clothes capacity in an unmarked vehicle. We were paying special attention to the area of S.Willow St near the mall during the busy holiday shopping season. We then observed a male subject standing on the I-293 westbound off ramp onto S. Willow St holding a cardboard sign solicting money from passing vehicles. The male's back was towards the traffic light and he was facing approaching traffic, holding the sign in attempt to obtain the drivers attention. After several light cycles, we then noticed that the light cycle turned green and the long line of vehicular traffic proceeded westbound onto S.Willow St. A white SUV then stopped in the roadway while the light cycle was green, and handed the male, who was subsequently identified as

what appeared to be money. This caused all the vehicles traveling behind this stopped vehicle to come to a complete stop during the green light cycle. After handing Tilton the money, the vehicle proceeded and several of the vehicles following then became stuck at the traffic light that cycled to red.

At this point, we approached Tilton and identified ourselves as Manchester Police Officers, while displaying our badge. We informed Tilton that he would be issued a white summons to appear in court for Disorderly Conduct (V) for

obstructing vehicular traffic. Tilton stated that he didn't think he did anything wrong. I then explaind to Tilton that he was allowed to panhandle and that it was his constitutional right to do so. However, I advised Tilton that he was not allowed to commit other violations such as obstructing vehicular traffic. I then issued Tilton a white summons to appear in Manchester District Court, 9th Circuit on January 23, 2016 for one count of Disorderly Conduct (V), 644:2 at 0815 hrs. I also provided Tilton with information on services that were available to her and where he could seek help as well.

On 12-06-2015 myself and Officer T. Battistelli were in plain clothes working in the southend of the city. We were both equipped with the proper equipment needed in our daily functions as police officers. We were in a department issued undercover police car equipped with lights, siren, and radio. As we were traveling in the southend we were dawn to a male that was on the side of the exit ramp from Rt 293 near S Willow St. (exit 1) He was holding a sign and facing the vehicles coming up the ramp and stopping at the red light to go north and south on S Willow St. We pulled over and watched the actions of this male. It was approximately 1100 hours and the traffic was fairly heavy at this time as vehicles were coming and going form the Mall of New Hampshire. We watched the light for traffic to turn onto S Willow St turn green. As the vehicles went through the green light a tan vehicle, several cars back, stopped and handed an item to the male.
