On 12-1-15 I was assigned to the Community Policing Division operating a fully marked cruiser and wearing a police mountain bike uniform. At approximately 1130 hours I began paying special attention to the area of Interstate 293 and South Willow St. There have been several subjects standing at each corner for the last several weeks collecting money and items from passing vehicles. When I arrived I observed a female standing on the east side of South Willow St at the west bound off ramp. She was holding a sign which stated she was homeless and asking for help. She was later identified as:

Candace Neal [REDACTED]

Shortly after arriving I observed the traffic turning south onto South Willow St from 293 begin to move as the light had turned green. The second vehicle in line in the lane closest to Neal moved forward but then stopped to pass something to Neal. This sudden stop caused approximately the next four vehicles in line to stop unexpectedly and wait for the second vehicle to begin moving again. Neal reached out to the stopped vehicle and took something.

Once the traffic was clear I made contact with Neal and explained that her actions had caused the traffic to be disrupted and issued her a white summons for Disorderly Conduct (V).

Mo: Woman obstructs the flow of traffic on off ramp turning on to S Willow St

On 12-05-2015 Officer Ed Devereaux and I (Ofc Ju Maguire) were working in a plain clothes operation. We were watching the area of the Mall of New Hampshire for illegal activity. We were both wearing undercover clothes with our police issued badges affixed around our neck. We were in a Manchester Police unmarked cruiser which had police lights, sirens, and radio. Officer Devereaux and I set up and started to watch a woman panhandle for money on the off ramp eastbound onto S Willow St. (exit 1) She was standing on the sidewalk and holding a cardboard sign facing traffic as they approached her. As we continued to watch, the red light turned green for all the traffic to move onto S Willow St and head north. As several cars went through the green light a vehicle then stopped in the far left hand lane. The person handed something to this woman and the woman took it. As this took place all the vehicle traffic behind her had to stop and could not proceed through the green light. As the vehicle pulled away several other vehicles were able to make the green light, but some missed the light cycle due to having to wait for the woman to retrieve the item.

She was issued a white summons to appear at Manchester District Court on 01-12-2016 at 0815 hours. I gave her the pink copy and we left the area. Nothing further.

After several light cycles, we then noticed that the light cycle turned green and the long line of vehicular traffic proceeded westbound onto S. Willow St. A white SUV then stopped in the roadway while the light cycle was green, and handed the male, who was subsequently identified as

We were both equipped with the proper equipment needed in our daily functions as police officers. We were in a department issued undercover police car equipped with lights, siren, and radio. As we were traveling in the southend we were down to a male that was on the side of the exit ramp from Rt 293 near S Willow St. (exit 1) He was holding a sign and facing the vehicles coming up the ramp and stopping at the red light to go north and south on S Willow St. We pulled over and watched the actions of this male. It was approximately 1100 hours and the traffic was fairly heavy at this time as vehicles were coming and going from the Mall of New Hampshire. We watched the light for traffic to turn onto S Willow St turn green. As the vehicles went through the green light a tan vehicle, several cars back, stopped and handed an item to the male.
