The panhandler was holding a large cardboard sign at chest level that said "Veteran" and had smaller writing underneath it. She was standing on the grass between the sidewalk and the roadway on the west side of Maple St approx 15 feet south of Bridge St. Maple St is a 2 lane one way street at that point heading north. The panhandler was standing with her back to the traffic control device while facing northbound traffic.

While watching her I saw approx 7 vehicles hand her items. During a green light cycle for vehicles traveling north on Maple St a black Cadillac came to a complete stop and handed her something.
