#### **Queen City man arrested for burglary**

Officer Chris Cunningham responded to Gabby's Fashion, located at 342 Union Street, for a burglary at 11:40 p.m. on March 3<sup>rd</sup>. He met with the complainant who played a surveillance video for the officer. Officer Cunningham relayed the description to officers on the street

After hearing the description Officer Mike Caron located two individuals approximately 15 minutes later in the area of Central and Pine Streets. One of the individuals, later identified as *arrested; Eliberto Claudio*, *46-years of age*, *Manchester*, *NH* was allegedly in the area arguing with a second subject, identified as Senesie Bai, 33-years of age. Claudio matched the description provided by Officer Cunningham.

Officer Caron began speaking to the individuals when Claudio became loud and boisterous, which caused a nearby resident to leave her apartment to check on the activity. Officer Caron ultimately located clothing articles nearby and determined the items had been taken during the burglary. He received enough probable cause to arrest Claudio, who was subsequently *charged with Burglary and Disorderly Conduct*. He will appear in the 9<sup>th</sup> Circuit Court-Manchester on March 4, 2015.

Officer Caron did not believe Bai was involved in the burglary, so he was released from the scene and was not charged with a crime.

Multi-agency investigation leads to 3 arrests

Multiple agencies engaged in an 8 month long drug investigation made three arrests yesterday and seized over 300 grams of heroin (street value over \$37,000) and approximately \$16,500.00 in United States currency.

Members of the Manchester Police Department Special Enforcement Division, S.W.A.T. team and New Hampshire State Police-Narcotics Investigative Unit started surveillance on the target of the investigation in the early morning hours of March 3, 2015.

The subject; *Christopher Chapman, 33-years of age, Manchester, NH* was located and arrested outside of Hillsborough County Superior courthouse at 9:00 a.m. yesterday. He was taken into custody on an arrest warrant for Sale of a Controlled Drug (1 count) based on the 8 month long investigation.

The Manchester Police S.W.A.T. team approached his Lawton Street apartment a short time later and executed a search warrant. They located and seized *12.8 grams of heroin* (street value approximately \$1,200.00), *4-8mg Suboxone* (street value approximately \$32.00) and over *\$16,500.00* in United States currency.

Chapman was also *charged with; Possession with Intent to Distribute and Possession of a Controlled Drug.* He will appear in the 9<sup>th</sup> Circuit Court-Manchester on March 4, 2015.

A second person was arrested outside of the Lawton Street apartment house. Police officers on scene were approached by the building owner (later arrested), *Alfredo Valentin*, *43-years of age*, *Manchester*, *NH*. Valentin allegedly became hostile toward the police officers on scene and refused to leave the area. Next, he allegedly began audio recording a conversation between two police officers involved in the investigation. New Hampshire requires two party consent when audio recording individuals, so Valentin was immediately placed into custody and transported to police headquarters.

Valentin was charged with Interception and Disclosure of Telecommunication or Oral Communication Prohibited (F) and was released on \$1,000.00 personal recognizance bail. He is scheduled to appear in the 9<sup>th</sup> Circuit Court-Manchester on April 9, 2015.

The investigation continued throughout the day and a third subject was located and apprehended in Lawrence, Massachusetts. Members of the Massachusetts State Police Drug

Task Force assisted in locating and arresting the male subject allegedly involved in distributing large quantities of heroin throughout the southern portion of New Hampshire and northern Massachusetts.

The man was in possession of a fraudulent identification and has yet to be positively identified. Investigators also located and seized over 300 grams of heroin, worth an estimated street value of \$36,000.00 dollars.

The professionalism, multi-jurisdictional team work and hard work paid off yesterday when investigators removed over 312 grams of heroin off of the streets of New Hampshire and Massachusetts.

### Stabbing sends one to hospital and another to court

Officer Jonathan Makara was patrolling the area of the Pericles Club, 127 Spruce Street around 1:00 a.m. and witnessed an altercation involving two men. One of the men was allegedly beating another man as he lay on the ground. Officer Makara attempted to stop the altercation, but as he approached one of the men fled on foot.

Officer Makara engaged in a foot pursuit and gave chase for several blocks. He and Officer Jeff Fierimonte were able to apprehend the subject and place him into custody. The male was identified as arrested; *Davelle Broadus*, *29-years of age*, *Manchester*, *NH*.

Several officers arrived on scene at the Pericles Club and located the victim of the assault. The 30-year old victim originally observed on the ground was bleeding profusely from his abdomen and was allegedly losing consciousness. Sergeant Richard Brown, Officer's Mike Caron and Ken Brunini all took part in rendering emergency aid to the victim.

The victim was transported to a local hospital and received treatment for multiple stab wounds. He is still hospitalized and being treated for his severe, but non-life threatening injuries. The investigation is ongoing and it is unknown if the man arrested actually stabbed the victim. Therefore, *Broadus is charged with Resisting Arrest and placed on a 72-hour hold for a Probation/Parole Violation.* He will appear in the 9<sup>th</sup> Circuit Court-Manchester on March 4, 2015. Additional charges may be forthcoming.
